PURCHASE PRICE AND PAYMENT

The buyer agrees to pay the total purchase price of \$_____ for the above-mentioned puppy. Payment shall be made as follows:

HEALTH GUARANTEE

The breeder certifies that the puppy is in good health at the time of sale and has received appropriate vaccinations and deworming treatments as per the puppy's age. A record of vaccinations and treatments will be provided to the buyer.

The buyer agrees to have the puppy examined by a licensed veterinarian within [number of days] days of taking possession. If the veterinarian certifies the puppy as medically unfit within this period, the buyer may return the puppy for a full refund of the purchase price or choose to keep the puppy and receive reimbursement for reasonable veterinary expenses, up to the purchase price, with proper documentation.

SPAY/NEUTER AGREEMENT

The buyer agrees to have the puppy spayed/neutered by a licensed veterinarian within [number of months] months from the date of purchase. Proof of spay/neuter must be provided to the breeder. The buyer acknowledges that failure to comply with this agreement may result in legal action and forfeiture of ownership of the puppy.

OWNERSHIP AND REGISTRATION

The breeder guarantees that they are the legal owner of the puppy and have the right to sell it. The breeder will provide the necessary registration documents, if applicable, to the buyer within a reasonable time after purchase.

TRANSFER OF OWNERSHIP

The transfer of ownership will take place upon receipt of the full payment by the breeder. The buyer agrees to provide a safe and suitable environment for the puppy, including proper shelter, nutrition, and veterinary care.

RETURN POLICY

If, for any reason, the buyer is unable to keep the puppy, the breeder must be notified first. The breeder has the right of first refusal and may choose to take back the puppy or assist in rehoming. No refund will be provided unless agreed upon by both parties in writing.
